#### Report on the Audit of the Financial Statements

#### **Opinion**

We have audited the financial statements of **THAI – JAPANESE DEVELOPMENT ASSOCIATION.** which comprise the statement of financial position as at March 31, 2019, and the statement of revenue and expenses statement and statement of changes in equity for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of **THAI-JAPANESE DEVELOPMENT ASSOCIATION** as at March 31, 2019, and its financial performance for the year then ended in accordance with Thai Financial Reporting Standards for Non-Publicly Accountable Entities.

#### **Basis for Opinion**
